



LOCKER RENTAL AND POLICY FORM

Lockers for storage of personal items are available to all Smitty's Performing Arts Center students. Dancers must apply and pay for locker rental before the published deadline each season to be given priority status locker placement. Lockers and combination locks are non-transferable.

Locker assignments will remain from September through June. The director of Smitty's P.A.C. retains the right to adjust or terminate locker rentals based on class enrollment or student behavior. Combination locks are issued to dancers upon assignment of a locker. Dancers should keep lockers locked at all times. Dancers are cautioned against sharing their locker combination with each other. Smitty's P.A.C. shall not be responsible for lost or stolen items. Each dancer is responsible for keeping his or her locker clean inside and out. Damages caused by misuse will be charged to the dancer responsible. Do not keep perishable food items in your locker. Foul smelling lockers will not be permitted. If complaints of foul odors are reported, the items will be removed from the locker and a \$20.00 fee will be charged to the dancer's account. Any locker malfunction should be reported to the office management.

Cost of a locker is \$75.00 per dance season (Sept-June or any part thereof). No prorates, refunds, or credits are available for locker rental fees, including termination of locker privileges by the director. Dancers must use Smitty's locks. Personal locks may not be substituted. Personal locks will be cut off and the dancer's account will be charged \$20.00. Cost to replace a Smitty's lock is \$15.00. Locker searches will occur when and where there is reasonable suspicion that the contents in a locker may contribute to the disruption of the education process within the center. All lockers are property of Smitty's P.A.C. and will remain at all times under control of Smitty's P.A.C. Dancers may not go to their lockers during class without permission from their instructor. Dancers are expected to assume full responsibility for the contents of their lockers. Periodic general inspections of lockers may be conducted by Smitty's authorities, without warning, without dancer consent, and without a search warrant. Having a locker is a privilege, not a right.
